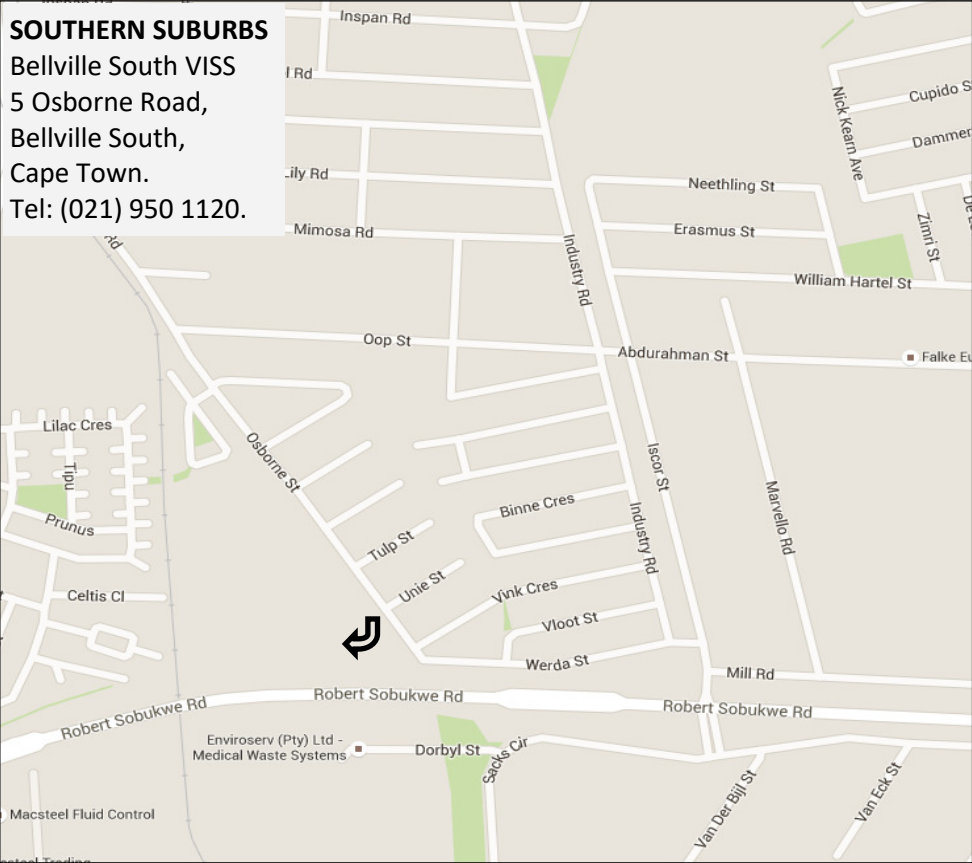
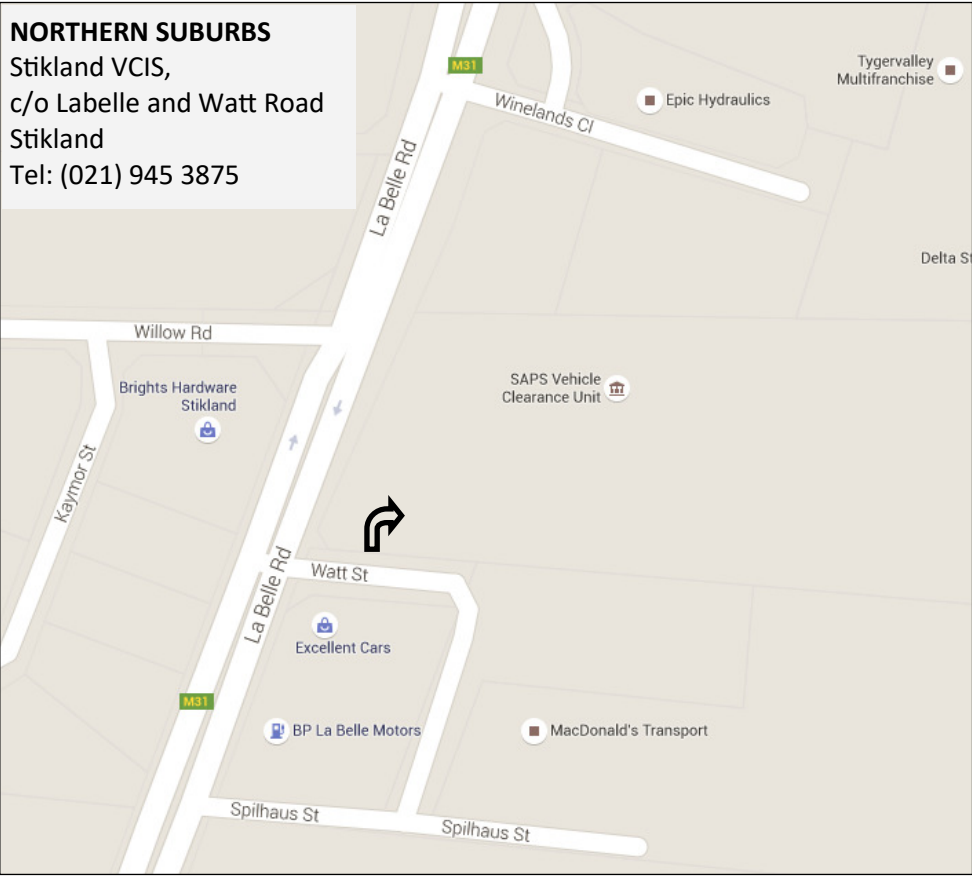


MOTOR VEHICLE EXPORT PROCEDURE

STEP 1

GET RPC FORM FROM ANY TRAFFIC DEPARTMENT

YOU WILL NEED:

- TWO COMPLETED CNV FORMS TO MARK VEHICLE AS EXPORT
(THIS FORM CAN BE DOWNLOAD ON OUR WEBSITE)
- COMPLETE RPC REQUEST FORM
(THIS FORM CAN BE DOWNLOAD ON OUR WEBSITE)
- REGISTRATION PAPERS IN OWNERS NAME
- IDENTITY DOCUMENT OR PASSPORT OF OWNER

STEP 2

HAVE MICRODOT IDENTIFIER FITTED. NEW LEGISLATION IN SA NOW REQUIRES A MICRODOT IDENTIFIER TO BE FITTED TO ALL MOTOR VEHICLES THAT REQUIRE CLEARANCE BY SAPS (SHOULD YOUR CAR ALREADY HAVE MICRODOT IDENTIFIERS FITTED, THEN PLEASE IGNORE THIS ITEM FURTHER.)

YOU WILL NEED

- REGISTRATIONS PAPERS IN OWNERS NAME

STEP 3

GO TO SAPS VEHICLE CLEARANCE CENTRE THAT SERVICES YOUR AREA. SEE ADDRESSES AND MAPS ON LEFT. PLEASE BE SURE THAT YOUR ENGINE IS CLEAN AND THAT THE ENGINE AND CHASSISNUMBER ARE LEGIBLE AND THAT YOU KNOW THE LOCATION.

THEY WILL REQUIRE:

- REGISTRATION PAPERS IN OWNERS NAME
- IDENTITY DOCUMENT OR PASSPORT OF OWNER
- RPC FORM (FROM TRAFFIC)
- MICRODOT CERTIFICATE

STEP 4

RETURN THE RPC TO THE CLERK THAT HELPED YOU AT THE TRAFFIC DEPARTMENT TO HAVE VEHICLE UPDATED AS EXPORTED

THEY WILL REQUIRE:

- COMPLETED RPC FORM (FROM POLICE CLEARANCE)
- REGISTRATION PAPERS IN OWNERS NAME
- IDENTITY DOCUMENT OR PASSPORT OF OWNER

STEP 5

RETURN TO POLICE CLEARANCE WITH COPY OF RPC TO FETCH YOUR SAPS 263 CLEARANCE DOCUMENT

THEY WILL REQUIRE:

- COPY OF RPC FORM (FROM TRAFFIC)
- REGISTRATION PAPERS IN OWNERS NAME
- IDENTITY DOCUMENT OR PASSPORT OF OWNER

STEP 6

BRING US THE DOCUMENTS THAT YOU RECEIVED FROM THE SAPS VEHICLE CLEARANCE CENTRE AND WE WILL APPLY FOR YOUR EXPORT PERMIT. THIS WILL COST R975.00

WE WILL REQUIRE:

- COPY OF REGISTRATION PAPERS IN OWNERS NAME
- COPY OF IDENTITY DOCUMENT OR PASSPORT OF OWNER
- COPY OF RPC FORM (FROM TRAFFIC)
- COPY OF SAPS 263 FORM (FROM SAPS)
- COPY OF MICRODOT CERTIFICATE

PLEASE NOTE THAT BEFORE YOU CONSIDER SHIPPING YOUR VEHICLE, ENSURE THAT IT MEETS THE REQUIREMENTS OF THE COUNTRY YOU ARE SHIPPING IT TO.

UNITED KINGDOM

Proof of Ownership to show the vehicle has been owned for at least 6 months prior to shipping - purchase receipt or registration document

Proof of Usage to show the vehicle has been used for at least 6 months prior to shipping - insurance documents, service documents or proof of usage.

Proof of Residence for 12 months prior to shipping- utility bills
